Bids must be delivered to the address below at 8(a) at or before **10:30AM East African time on August 10, 2021.** The bid must be accompanied by a bid security amounting to **Ugx 24,000,000** or an equivalent amount in a freely convertible currency and in the form of a Bank guarantee issued by a Bank located in Uganda or a foreign Bank through correspondence with a Bank located in Uganda. Late bids shall be rejected and no liability will be accepted. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below at 8(a) **11:00 AM East African time on August 10, 2021.**
