2. The NWSC therefore invites sealed bids from eligible bidders for the supply of assorted GI Pipes for New Connection under framework contract for a period of 18 months.
3. Bidding will be conducted in accordance with the Open Domestic Bidding procedures contained in the Public Procurement and Disposal of Public Assets Act, 2004, of Government of Uganda. This invitation is open to all eligible bidders.
